

ANU Chancellor's International Scholarship: Frequently Asked Questions

General Questions

Is there a separate application for the ANU Chancellor's International Scholarship?

There is no separate scholarship application. All eligible international students applying for admission in Semester 1 2021 will be automatically considered.

Will the ANU Chancellor's International Scholarship be available for future intakes (other than Semester 1 2021)?

The ANU Chancellor's International Scholarship has only been approved for Semester 1 2021. The ANU Chancellor's International Scholarship is currently only available for students commencing in Semester 1 2021.

What can this scholarship be used for?

The ANU Chancellor's International Scholarship is a tuition fee waiver scholarship. The scholarship value will be applied to your outstanding fees in Semester 2 2021.

Concurrent Holding of Awards

Are students able to hold two scholarships at the same time?

Yes, the ANU Chancellor's International Scholarship can be held jointly with another ANU scholarship, depending on the conditions of the other scholarship.

Certain ANU scholarships cannot be combined with another tuition fee waiver scholarship. Please read the conditions of award of the other scholarship carefully to ensure whether it can be held along with another ANU scholarship.

Example:

Recipients **can** hold an ANU Chancellor's International Scholarship and a *living stipend* offered by another ANU department.

Recipients **cannot** hold an ANU Chancellor's International Scholarship with a *tuition fee reduction* scholarship offered by another ANU department.

Can students hold two ANU Chancellor's International Scholarships at the same time?

Unfortunately, students cannot hold two ANU Chancellor's International Scholarships at the same time.

Example:

An IB student applying for an undergraduate degree from India, will be considered for three categories, but may only receive the offer for one of these.

Will students holding an external government sponsorship be eligible for the ANU Chancellor's International Scholarship?

Students must be self-funded in order to be eligible for the ANU Chancellor's International Scholarship. Unfortunately, this means that students funded by an external government will not be eligible for these scholarships.

COVID-19 Specific Queries

Can students defer the scholarship offer to Semester 2, 2020 if they are unable to travel due to the COVID-19 travel restrictions?

The ANU Chancellor's International Scholarship has only been approved for Semester 1, 2021. The ANU Chancellor's International Scholarship is currently only available for students commencing in Semester 1 2021, and as such the scholarship offer cannot be deferred. Students can enrol remotely if the University permits.

Scholarship Payment Information

Will the scholarship amount be deducted from the outstanding tuition fees, or will it be paid into the student's bank account?

The tuition fee deduction will be applied to the outstanding tuition fees for Semester 2 2021.

Do students still need to pay the full amount for deposit, or will this be reduced if they accept the scholarship offer? How much deposit will they need to pay?

The scholarship will be applied to tuition fees in Semester 2 2021 to avoid any issues with deposit and overpayment. As such, students still need to pay the full amount for the deposit (as per the offer letter) and any remaining Semester 1 2021 tuition fees. The benefits of the scholarship will be applied in Semester 2 2021 only.

Partner University Students

Will students from a partner university, applying for programs such as the 2+2 program, be eligible for the ANU Chancellor's International Scholarship?

Yes, students from partner universities will essentially be enrolling to the ANU for the first time, and hence will be considered for the scholarship.

Applicants from partner universities do not apply using the standard international application process. How will students who apply from partner universities and receive their offers either before or after the standard ANU offer release dates be considered for, and informed about, this scholarship?

ANU will obtain a list of full offer-holders, including partner university offer-holders, prior to the cut-off date for each round. Applicants from partner universities will be considered based on their basis of admissions and ranked against the relevant cohort according to the round timelines.

Transfers, Change of Preference, and Deferrals

Will international students who deferred their offers for Semester 2 2020 be included in the automatic considerations?

International students who deferred their enrolment to Semester 1 2021 will be considered for the ANU Chancellor's International Scholarships. These candidates will have to be re-assessed for the academic offer in Semester 1 2021, and therefore will be automatically included in the assessment round for the scholarships.

If awardee/s decline an ANU Chancellor's International Scholarship offer, or choose another scholarship, would other students be re-considered?

ANU will only release a portion of the scholarships in each round.

A number of offers will be made in each round, with the scholarship offer going out the same day as the academic offer (next day for Round 3). If a student has not received a scholarship offer within a day or two of receiving their academic offer, they haven't received this scholarship and will not be considered a second time in that round.

Any offers not taken up in a particular round will be rolled over to the next round. No 'late' offers will be made.

How will the scholarship offer and eligibility be impacted if students change their preference in the following round?

The scholarship offer will be made on the same day as the academic offer in each round. If a student does not receive a scholarship offer in Round 1, they may choose to change their preference, but they will forfeit the academic offer they received in Round 1. If they choose to do this, they will be considered against the Round 2 cohort, for both academic offer and scholarship offer.

If a student receives a scholarship offer in Round 1 but they want to change their preference and be considered for a different academic offer in Round 2, they may keep their scholarship offer.

However, they must be successful in receiving a new academic offer to take up the scholarship.

Do the ANU Chancellor's International Scholarships apply to students who are progressing through ANU College programs into relevant undergraduate programs next year, or to students transferring from other foundation or mainstream programs offered by other universities?

Current ANU College students who are completing ANU Foundation or a Diploma will be considered for the scholarships. Students completing foundation programs at other universities, or transferring from other universities, will be considered as well.

Please note that the ANU Chancellor's International Scholarships are highly competitive and selection will be made based on academic merit.

If I don't receive an academic or scholarship offer in one round, will I automatically be considered in the next round?

If a student does not receive an academic offer in Round 1, they will be considered for academic and scholarship offers in the Round 2.

If a student receives an academic offer but does not receive a scholarship offer in Round 1, they may choose to change their preference, but they will forfeit the academic offer they received in Round 1. If they choose to do this, they will be considered against the Round 2 cohort, for both academic offer and scholarship offer.
