**TERRELL INTERNATIONAL UNDERGRADUATE SCHOLARSHIPS**  
CONDITIONS OF AWARD

**1. INTRODUCTION**

To commemorate the contribution of Professor R D Terrell to international relations and international student affairs, the University has established a number of scholarships to be awarded to international undergraduate students on the basis of their achievement in their enrolment at the Australian National University. The scholarships will be called the Terrell International Undergraduate Scholarships.

**2. VALUE**

- 2.1 There will be a number of 50% and 25% tuition fee sponsorship scholarships available each year.
- 2.2 The 50% scholarship will cover 50% of the cost of the tuition fees for each semester for the remaining duration of the scholar's undergraduate program or combined program (including an Honours Year) registered by the University on CRICOS, and the cost of the Overseas Student Health Cover (100%).
- 2.3 The 25% scholarship will cover 25% of the cost of the tuition fees for each semester for the remaining duration of the scholar's undergraduate program or combined program (including an Honours Year) registered by the University on CRICOS, and the cost of the Overseas Student Health Cover (100%).
- 2.4 The Scholarships will not include any cash stipend, or cover for travel, removal or incidental costs. The scholar is responsible for paying the outstanding balance of all of his/her tuition fees after the scholarship has been applied, by the prescribed date as set out by the University each session. The scholar is responsible for the costs of books, study materials, accommodation and all other costs of study.

**3. ELIGIBILITY**

The Scholarships shall be available for award each year to international students:

- (a) who have completed up to and no more than two semesters at the University and will enrol into their second year;
- (b) who are enrolled in a Bachelor's degree program at the University;
- (c) who have achieved excellent results during their first two semesters at the University.

**4. APPLICATION**

Applications shall be via an online form available on the web. Applications must be submitted on the online form by the prescribed date each semester.

**5. SELECTION**

- 5.1 The Scholarships shall be endorsed by the Registrar and approved by the Chair of the University Awards Committee.
- 5.2 The Scholarships will be awarded from a ranked list. Applications will be assessed on the basis of academic merit using the results achieved during the first two semesters at the University.

## **6. CONCURRENT HOLDING OF SCHOLARSHIPS**

- 6.1 Scholars must seek permission in writing from the Chair of the University Awards Committee to hold other scholarships/awards concurrently with the ANU Terrell International Undergraduate Scholarships.
- 6.2 The total value of all scholarships/awards held by the scholar, including the ANU Terrell International Undergraduate Scholarship, cannot exceed the total cost of his/her tuition fees each year.

## **7. DEFERMENT**

The Scholarship may not be deferred, unless otherwise approved by the University Registrar.

## **8. COMMENCEMENT**

The Scholarship commencement date shall be outlined in the formal scholarship letter of offer.

## **9. LEVEL OF PERFORMANCE**

ANU Terrell International Undergraduate Scholarship holders are expected to maintain a distinction (70%) average each semester (with the average being across all courses taken in a particular semester).

If a scholar is unable to achieve a distinction average in their previous semester they will be sent a formal warning.

If a scholar does not meet the distinction average in a subsequent semester they will risk having their scholarship suspended or terminated.

Scholars will be given the opportunity to explain their performance and how their performance can be remedied before a decision on the suspension or termination of a scholarship is made.

## **10. TENURE**

The Scholarships will be awarded for the remaining duration of the scholar's undergraduate program or combined program (including an Honours Year) registered by the University on the Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS).

## **11. ENROLMENT**

- 11.1 Scholars must remain enrolled on a full time load during the tenure of the Scholarship.
- 11.2 With the approval of the Chair of the University Awards Committee, the Scholarship may be suspended for a maximum total period of one year. Scholars must seek approval to take academic program leave from the Education Dean of the relevant ANU College.
- 11.3 A scholar who wishes to transfer to another undergraduate degree program must obtain written approval from the Chair of the University Awards Committee to retain the Scholarship. The Scholarships will not be extended beyond the original minimum program duration.

## **12. TERMINATION**

The University may terminate the Scholarship if:

- (a) in the opinion of the Chair of the University Awards Committee, the scholar has failed to achieve at the appropriate level;
- (b) the scholar withdraws, abandons or otherwise terminates their candidature at the University.



**13. TAXATION**

Scholars are responsible for seeking taxation advice regarding their own individual circumstances. Please note that scholarships may be regarded as taxable income if a scholar is enrolled on a part time basis.

**14. PERMANENT RESIDENCY IN AUSTRALIA**

Scholars who obtain Australian Permanent Residence will cease to be eligible to hold the Scholarship from the end of the semester in which they receive Permanent Residence Status.

**15. PUBLICITY**

It is anticipated that ANU Terrell International Undergraduate Scholarship holders may be requested to participate in publicity of the Scholarships from time to time. Scholars may be contacted for an interview and photograph. The University may also publicise the scholarships by publishing the names of the scholars. Arrangements for such publicity will be made through the Communications and External Liaison Office of the University.

**16. DISCLAIMER**

The award of a scholarship does not carry an commitment by the University for future employment.
